## Legislative

MRLDA had a successful year in 2016 as we fought for reforms to strengthen lien laws, fought against an attempt to pass data liability to retailers, and saw great responses to grassroots outreach from members. MRLDA will continue to represent the lumber and building material industry in Boston by focusing on these issues in 2017:

### Lien Laws

MRLDA continues to work with the state homebuilders to strengthen the state lien laws in the face of numerous court rulings that stripped many rights out of the lien laws. MRLDA continues to advocate for the rights of dealers as material suppliers to make sure their businesses are protected and that homeowners are fully informed of the rights of materialmen working on their projects.

### Data Liability

There was an attempt to push liability for data breaches and the cost of sending out new cards and protections from the banks to the retailers. MRLDA fought against this attempt and stood up against the attempts from the banks to pass their liability, especially in light of their refusal to use new security measures available, to retailers.

### Grassroots

MRLDA made grassroots outreach to legislators a main focus and hosted numerous successful yard tours where legislators learned much about the industry and members and how much they contribute to the state and economy. MRLDA will use these strengthened relations to lobby issues in 2017 and beyond.
